AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Aberdeen School District No. 5 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student enrollment reporting
- Use of restricted funds professional learning
- Establishment of local revenue and expenditure accounts
- Self-insurance for health and welfare
- Payroll bonus and incentive payments
- Electronic funds transfers accounts payable and payroll
- Associated Student Body activities at Aberdeen High School fundraisers and ticket sales

INFORMATION ABOUT THE DISTRICT

Aberdeen School District No. 5 provides educational services to approximately 3,500 students in pre-school through 12th grade in Grays Harbor County. The District has five elementary schools, one junior high, one traditional high school and one alternative high school, and one Alternative Learning school for grades 3 - 12.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 500 employees. For the 2018-2019 fiscal year, the District operated on an annual budget of approximately \$52 million.
