AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Castle Rock School District No. 401 from September 1, 2017 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Cash receipting timeliness and completeness of deposits, voids and adjustments at Castle Rock High School
- Payroll gross wages, leave balances and accruals, leave cash outs, and bonus and incentive payments
- Accounts payable general disbursements and credit cards
- Student enrollment reporting Special Education
- Establishment of local revenue and expenditure accounts
- Use of restricted funds professional learning

- Electronic funds transfers payroll and accounts payable
- Open public meetings documentation of minutes and executive sessions

INFORMATION ABOUT THE DISTRICT

Castle Rock School District No. 401 is located primarily in Cowlitz County, serves approximately 1,390 students from kindergarten through 12th grade, and has approximately 205 employees. The District operates one high school, one middle school, and one elementary school in Castle Rock, WA and operates a Pre-school in Vader, WA, located in neighboring Lewis County.

An elected, five-member Board of Directors has oversight of the District, appointing the management, setting the budget and holding other financial responsibilities. For fiscal year 2017-2018, the District had revenues of approximately \$16.4 million. For fiscal year 2018-2019, the District had revenues of approximately \$18.4 million.
