#### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters that we communicated to District management and Board of Directors in a letter dated May 18, 2020 related to credit card disbursements. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Cusick School District No. 59 from September 1, 2017 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student alternative learning experience reporting
- Use of restricted funds professional learning
- Establishment of local revenue and expenditure accounts
- Accounts payable credit cards, and electronic funds transfers
- Payroll leave cash outs

## INFORMATION ABOUT THE DISTRICT

Cusick School District No. 59 provides educational services to approximately 250 students from kindergarten through 12th grade in Pend Oreille County.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints management to oversee the District's daily operations as well as its approximately 50 employees. For fiscal years 2018 and 2019, the District operated on annual budgets of \$4 million and \$4.5 million, respectively.
