AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Edmonds School District No. 15 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – general disbursements, credit cards, and electronic funds transfers
- Use of restricted funds – professional learning
- Establishment of local revenue and expenditure accounts
- Procurement – public works, cooperatives and purchasing exemptions
- Associated Student Body activities at Edmonds-Woodway High School – ASB card requirement
- Surplus equipment – disposition and receipt of sales proceeds
- Financial condition
- Open public meetings – documentation of meetings, executive sessions and special meetings

Financial

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. That report includes a federal finding regarding the District improperly claiming students as eligible through the Indian Education Grant to Local Education Agencies. INFORMATION ABOUT THE DISTRICT

Edmonds School District No. 15 provides public school services to students in preschool through 12th grade. The District has the highest enrollment in Snohomish County and is the 11th highest in the state. The District's service area covers approximately 36 square miles in south Snohomish County and includes the communities of Brier, Edmonds, Lynnwood, Mountlake Terrace and Woodway and portions of unincorporated Snohomish County. The District serves approximately 20,098 students in grades K-12 with a staff of approximately 2,293 employees. The District operates one preschool, two K-8 schools, two K-12 schools, 20 elementary schools, four middle schools and five high schools, plus an online high school.

The District's budgeted expenditures for the 2018-2019 school year were \$332,620,747 for the General Fund, \$3,088,846 for the Associated Student Body Fund, \$52,310,975 for the Debt Service Fund, \$54,530,435 for the Capital Projects Fund and \$2,000,000 for the Transportation and Vehicle Fund. A five-member Board of Directors, elected to four-year terms by the District's voters, governs the District's operations.
