#### NO ACTIVITY AUDIT SUMMARY

This no activity audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. State law also requires local governments to prepare, certify to, and submit annual reports to our Office summarizing, among other things, all collections made, amounts receivable or payable, expenditures made and debt owed. In its annual report submission to our Office, the Cemetery District certified that it had no financial activity from January 1, 2018 through December 31, 2019.

Because there was no reported activity, the procedures we performed were limited to verifying the annual reports submitted to our Office were complete and filed timely in compliance with state law, and corroborating the Cemetery District's certification of no activity by comparing its reported annual revenues, expenditures and cash and investment balances to third-party sources.

Based on the limited procedures performed, except as described below, nothing came to our attention that indicated the Cemetery District was not in substantial compliance with annual report filing requirements. Had we performed additional procedures, other matters might have come to our attention that would have been reported.

As referenced above and described in the attached finding, the Cemetery District should ensure that annual reports are completed and submitted within 150 days after its fiscal year end in accordance with state law. This recommendation is included with our report as a finding.

# 2019-001 The District's internal controls over financial reporting were inadequate to ensure timely reporting.

#### Background

The Board of Commissioners, management, state and federal agencies, and the public rely on the information included in financial statements and reports to make decisions. The District is responsible for designing, implementing and maintaining internal controls that provide reasonable assurance regarding the reliability of financial reporting.

State law (RCW 43.09.230) requires the District to submit an annual financial report to our Office no later than 150 days after the end of the District's fiscal year. The annual financial report includes summaries of financial information, supporting schedules, and responses to statutorily required compliance requirements.

The District received a disclaimer letter in the previous audit for not filing its 2015, 2016 and 2017 annual reports.

# Description of Condition

The District did not take appropriate action to prepare or submit the required annual reports within 150 days after its fiscal year end for fiscal year 2018.

# Cause of Condition

The District did not dedicate the necessary resources to ensure it submitted the 2018 annual report on time.

# Effect of Condition

The District filed its 2018 annual report 293 days late and the 2019 annual report on time. Delays in the availability of complete financial reports prevent District officials, the public and other interested parties from obtaining timely information. Such delays also hinder transparency to citizens and the efforts of the State Auditor's Office to compile statistical and financial information for use by the state Legislature and others.

#### Recommendation

We recommend the District establish internal controls to ensure timely financial reporting in accordance with state law.

#### Cemetery District's Response

Balance sheets have been corrected as per suggestions from the Auditors office. With the help of the state Auditor's office there is now a much clearer understanding of which documents are required to be filed and when.

#### Auditor's Remarks

We appreciate the District's commitment to resolve this fining and thank the District for its cooperation and assistance during the audit. We will review the corrective action taken during the next regular audit.
