AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters that we communicated to District management and Superintendent and Board of Directors in a letter dated June 23, 2020, related to procurement. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Sunnyside School District No. 201 from September 1, 2017 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student enrollment reporting
- Establishment of local revenue and expenditure accounts
- Use of restricted funds professional learning
- Accounts payable general disbursements and electronic fund transfers
- Procurement public works, purchases and professional services
- Self-insurance for unemployment compensation
- Payroll leave cash outs and additional pay
- Associated Student Body activities at the high school fundraisers and cash receipting

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE DISTRICT

Sunnyside School District No. 201, located in Yakima County, serves approximately 6,650 students in kindergarten through 12th grade. The District has five elementary schools, two middle schools and one high school through which it provides vocational education, bilingual education, pupil transportation, food services, special education and numerous special programs for remedial and enriched education.

A five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations. In fiscal year 2019, the District operated on an annual budget of \$102.6 million.
