#### AUDIT RESULTS

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of South Kitsap School District No. 402 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages and leave cash outs
- Tracking and monitoring of theft sensitive assets, such as computers and other information technology equipment
- Procurement public works, cooperative purchases, and professional services
- Contract compliance cash receipting and deposit timeliness
- Establishment of local revenue and expenditure accounts
- Use of restricted funds professional learning
- Associated Student Body activities at South Kitsap High Schools general disbursements

- Accounts receivable lunch account collections
- Compliance with Washington Administrative Code (WAC) requirements for monthly reports
- Financial condition
- Self-insurance for health and welfare

#### **INFORMATION ABOUT THE DISTRICT**

South Kitsap School District No. 402 operates ten elementary schools, three middle schools, one high school and two alternative schools. The District served approximately 9,300 full-time students during the 2018-2019 school year. The District has approximately 1,400 employees who provide an array of services in basic, special, and vocational education and supporting services such as: food and nutrition, health, maintenance and operations, transportation, student records, purchasing, human resources, financial, and administrative.

The District is administered by a five-member Board of Directors, which appoints a Superintendent to oversee the District's day-to-day operations. The District's general fund expenditures were approximately \$145 million for the year ended August 31, 2019.
