# AUDIT RESULTS

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

## About the audit

This report contains the results of our independent accountability audit of Everett Public Schools from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages, leave accruals and cash outs
- Student enrollment reporting
- Accounts payable electronic funds transfers
- Establishment of local revenue and expenditure accounts
- Use of restricted funds professional learning
- Tracking and monitoring of theft sensitive assets student laptops
- Financial condition
- Open public meetings documentation of minutes, executive sessions, and special meetings

### **INFORMATION ABOUT THE DISTRICT**

Everett Public Schools provides educational services to students in preschool through 12th grade in Snohomish County. The District serves parts of the cities of Everett and Mill Creek and areas of unincorporated Snohomish County. During the audit period, the District served approximately 20,170 students at four high schools, five middle schools and 18 elementary schools.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, six-year terms. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 2,300 employees. During the 2018-2019 school year, the District operated on a budget of approximately \$312.0 million.
