#### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Tribal School operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Chief Kitsap Academy from September 1, 2015 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Tribal School's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2018, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Basic enrollment reporting review support for students counts
- Special education enrollment reporting review for students eligibility
- Teacher (staff mix) reporting support for education and experience of staff
- Transportation review support for ridership counts
- General revenue and expenditures state funding and amounts paid to vendors
- Payroll support for amounts paid to certificated staff

## INFORMATION ABOUT THE TRIBAL SCHOOL

The Suquamish Tribal Education Department No. 902 established Chief Kitsap Academy in September 2014 as the first of three Washington State Tribal Compact Schools, located in Kitsap County. For school year 2018, Chief Kitsap Academy served approximately 73 students from six through 12th grade. The Suquamish Tribal Education Department campus operates a single 6-12 school, which includes middle school, and high school programs.

The school received approximately 1.7 million in direct state funding for fiscal year 2018. As a sovereign nation, the Suquamish Tribal Council has the ultimate control over the educational needs of the students attending the Chief Kitsap Academy.
