AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Agency operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Department of Transportation from July 1, 2018 through June 30, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the Agency's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended June 30, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements, electronic funds transfers, travel reimbursements, procurement cards, fuel cards, travel cards
- Payroll leave balances, new system implementation, electronic funds transfers
- Restricted funds Connecting Washington fund compliance
- Cash receipting timeliness and completeness of deposits of the commercial vehicle services and aviation divisions
- Inventory management fuel station tank inventories
- Fines, forfeits, & seizures review of account balance

Financial

We also perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE AGENCY

The Washington State Department of Transportation (WSDOT) is the steward of a multimodal transportation system and responsible for ensuring that people and goods move safely and efficiently. In addition to building, maintaining, and operating the state highway system, WSDOT is responsible for the state ferry system, and works in partnership with others to maintain and improve local roads, railroads and airports, as well as to support alternatives to driving, such as public transportation, bicycle and pedestrian programs.

The governor appoints the Secretary of Transportation who serves as the chief executive for the department. WSDOT's diverse programs and projects are supported by more than 6,600 full-time employees, including engineers, vessel captains, maintenance technicians, environmental specialists, planners, and many others.

WSDOT's Strategic Plan provides the vision, mission and values that guide the work of the agency. The Strategic Plan goals create a framework for agency decision-making and are focused in three key areas - Inclusion, Practical Solutions and Workforce Development. WSDOT's Inclusion efforts ensure the department engages with its employees, communities and partners as it collaboratively delivers the program. Practical Solutions allows the agency to leverage its limited funding to get the most capacity and safety out of the entire multimodal transportation system. The focus on Workforce Development ensures that the department attracts and retains a quality workforce to meet legislative, regulatory, service and public expectations.

The Legislature passed a 16-year transportation revenue package in 2015 referred to as "Connecting Washington" - a \$16.3 billion investment. The department is financed by revenue from fuel taxes, licenses, permits, fees, tolls, ferry fares, federal funds, and bond proceeds. The total 2019-2021 biennial budget is approximately \$6.65 billion.

As WSDOT delivers transportation services, it also works to identify lowest cost solutions and practical design principles to get the most efficient use of limited resources, preserve environmental quality, improve fish passage, and identify clean transportation opportunities to address climate change.

WSDOT's Headquarters is located in Olympia. The Department has six regional offices throughout the state:

- Northwest Region headquartered in Seattle
- Olympic Region headquartered in Tumwater
- Southwest Region headquartered in Vancouver
- North Central Region headquartered in Wenatchee
- South Central Region headquartered in Yakima
- Eastern Region headquartered in Spokane

Additionally, the department has approximately 470 facilities located throughout the state, including Ferry administration and terminals; project offices; Maintenance administration, shop and storage buildings; and program and modal headquarters.
