AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Waitsburg School District No. 401-100 from September 1, 2016 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student enrollment reporting
- Use of restricted funds – professional learning
- Establishment of local revenue and expenditure accounts
- Procurement – public works
- Accounts payable – general disbursements and electronic funds transfers
- Self-insurance for property, health and welfare, unemployment, and workers compensation
- Selected IT security policies, procedures, practices, and controls protecting financial systems, IT systems and data
- Financial condition

INFORMATION ABOUT THE DISTRICT

The Waitsburg School District No. 401-100 is a small rural kindergarten through 12th grade district in Walla Walla County. The District has about 275 students and employs a staff of about 22 certified and 20 classified employees.

An elected, five-member Board of Directors governs the District and appoints a Superintendent, who is responsible for the day-to-day operations. The District had annual revenues and expenditures of about \$4.6 million and \$4.6 million, \$4.9 million and \$6.9 million and \$5.0 million and \$6.9 million in fiscal years 2017, 2018 and 2019, respectively.
