AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to Associated Student Body (ASB) activities that we communicated to District management and Board of Directors in a letter dated September 28, 2020. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Lake Chelan School District No. 129 from September 1, 2016 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Establishment of local revenue and expenditure accounts
- Professional learning
- Associated Student Body (ASB) activities
- Payroll – leave cash outs, bonus payments
- Student enrollment reporting

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE DISTRICT

Lake Chelan School District No. 129 is located in Chelan County and serves approximately 1,900 students. The District has one high school, one alternative high school, one middle school, one elementary school and one remote kindergarten through 12th grade school.

An elected, five-member Board of Directors governs the District. The Board serves staggered, four-year terms. The Board appoints a Superintendent to oversee the District's daily operations and its approximately 230 employees. Most of the District's funding comes from state apportionments. The District operated with General Fund revenues of \$18,112,683 in 2017, \$19,227,928 in 2018 and \$20,611,900 in 2019.
