## AUDIT RESULTS

### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

### About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Skagit County from January 1, 2019 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll – gross wages, overtime, leave balances and accruals, benefit deductions, leave cash outs, performance incentives, retroactive payments, and electronic funds transfers
- Accounts payable – general disbursements, fuel cards, credit cards, and electronic funds transfers

## INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Skagit County, formed in 1936, provides water to approximately 70,000 citizens in Skagit County.

Skagit PUD is a municipal corporation governed by three elected commissioners, who serve six-year terms. The Board appoints a General Manager to oversee the District's daily operations as well as its approximately 85 employees. During fiscal year 2019, the District provided water services to its customers, leased dark fiber to Internet Service Providers (ISP's), and operated on revenues of approximately \$25 million.
