## AUDIT RESULTS

### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

### About the audit

This report contains the results of our independent accountability audit of the Spokane Regional Emergency Communications from March 27, 2018 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Authority's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Use of restricted funds
- Compliance with state law for entity creation
- Self-insurance for unemployment
- Financial condition

## INFORMATION ABOUT THE AUTHORITY

Spokane Regional Emergency Communications (SREC) is a public development authority originally incorporated in 2018 under the name Spokane Integrated Communications Public Development Authority.

The Authority has seven identified members and one nonvoting citizen representative that make up the governing board established exclusively to undertake, assist with, and otherwise facilitate the public function of providing emergency and non-emergency communications and emergency and non-emergency management services, including but not limited to dispatch, and to perform any other public function relating to providing such services as authorized by Washington State law or Spokane County code. Funding for SREC operations and activities include funds distributed to SREC from Spokane County as allowed under RCW 82.14B.030 and RCW 82.14.420. The Authority had annual expenditures of approximately \$95,500 in 2018 and \$6.8 million in 2019 for operations and administration.
