#### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to procurement for public works and purchases that we communicated to District management and Board of Directors in a letter dated December 17, 2020. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of North Spokane Irrigation District No. 8 from January 1, 2017 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable electronic funds transfers
- Procurement public works and purchases
- Self-Insurance for unemployment and workers compensation
- Financial condition

### INFORMATION ABOUT THE DISTRICT

North Spokane Irrigation District No. 8 serves approximately 900 customers in Spokane County.

The District is governed by an elected, five-member Board of Directors. The Board appoints a General Manager to oversee day-to-day operations. The District had annual budget of approximately \$551,000, \$607,000 and \$706,000 for fiscal years 2017, 2018 and 2019, respectively.
