#### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to a public works project performed with day labor that we communicated to District management and the Board of Commissioners in a letter dated December 17, 2020. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Klickitat Valley Health from January 1, 2018 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll software conversion, gross wages and leave balances and accruals
- Accounts receivable billing, adjustments and collections
- Self-insurance for health and welfare
- Accounts payable general disbursements and electronic funds transfers
- Procurement public works

- Compliance with public work projects prevailing wages, change orders, and retainage requirements
- Financial condition
- Surplus equipment disposition and receipt of sales proceeds
- Compliance with state grants
- Compliance with contract terms for orthopedic provider services

### INFORMATION ABOUT THE DISTRICT

Public Hospital District No. 1 of Klickitat County, doing business as Klickitat Valley Health, owns and operates a 25-bed critical access hospital, and rural health clinic, and a hospice agency. The District provides acute care and clinical services to patients in the Goldendale area. Services include acute care hospital, emergency, rural health clinic, hospice, and the related ancillary procedures (surgery, laboratory, imaging services, therapy, etc.) Medical staff includes specialists in emergency medicine, family practice, general surgery, radiology and pathology.

The District is governed by an elected, five-member Board of Commissioners. The Board appoints a Chief Executive Officer that manages daily operations. Management oversees the District's approximately 235 employees. The District derives most of its revenue (about 91 percent) from outpatient services. The District's budgeted operating expenses were \$25.7 million in 2018 and \$25.9 million in 2019.
