AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Renton Regional Fire Authority from January 1, 2019 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – electronic funds transfers
- Payroll – leave balances and accruals
- IT backup and recovery
- Open public meetings – documentation of minutes, executive sessions and special meetings
- Financial condition

INFORMATION ABOUT THE DISTRICT

Renton Regional Fire Authority was created on July 1, 2016 by voter approval. The Authority is a special purpose authority established to provide critical fire and life safety services to the residents of the City of Renton and King County Fire Protection District No. 25. The Authority also contracts with King County Fire Protection District No. 40 to provide services to that area. In addition to responding to and controlling all types of fires, the Authority responds to other emergency incidents including natural disasters, emergency medical services, hazardous materials response, and medical and property services calls.

A six-member Governance Board oversees the Authority. The Board is comprised of six voting board members and one non-voting member. The voting board members include three council members from the City of Renton and three commissioners from King County Fire Protection District No. 25. One commissioner representing King County Fire Protection District No. 40 serves as a non-voting board member. The Board appoints a Fire Chief to oversee the Authority's daily operations as well as its 175 employees. For 2019, the Authority operated on an annual operating budget of approximately \$41.08 million.
