AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the City of Dayton from January 1, 2017 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the City's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements, credit cards and electronic funds transfers
- Contract compliance cash receipting and deposit timeliness
- Procurement public works and professional services
- Financial condition
- Compliance with state grants Transportation Improvement Board (TIB)

INFORMATION ABOUT THE CITY

The City of Dayton was incorporated in 1882 and currently serves about 2,489 citizens. It is administered by a mayor-council form of government with seven elected Council Members and an independently elected Mayor. For 2017, 2018 and 2019, the City had about \$4.3 million, \$4.2 million and \$3.8 million in revenues, respectively and \$2.5 million, \$2.4 million and \$2.3 million in expenditures, respectively.

About 14 City employees provide services including public safety, law enforcement, street improvement, economic development and recreation through its parks and swimming pool. The City also provides water and sewer services and operates a cemetery.
