## AUDIT RESULTS

### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

### About the audit

This report contains the results of our independent accountability audit of the Northshore Utility District from January 1, 2019 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Financial condition – review for fiscal sustainability
- Payroll – review bonus incentives, comp-time, vacation, and sick leave payouts for accuracy, adequate support and compliance with policy
- Procurement – compliance with competitive bid law for public works project

## INFORMATION ABOUT THE DISTRICT

The Northshore Utility District was established in 1947 as King County Water District No. 79 to provide water distribution and wastewater collection services. In 1992, the District changed its name to Northshore Utility District. The District is located at the northeast corner of Lake Washington, and encompasses approximately 18.7 square miles to the areas of Kenmore, Lake Forest Park, West Bothell, Juanita, West Woodinville, Totem Lake, Kingsgate, Finn Hill, and North Kirkland. The District serves approximately 26,500 customers.

An elected, five-member Board of Commissioners serves as the governing body and has authority to set rates and charges for the District. Commissioners serve staggered, six-year terms. The Board appoints management to oversee the District's daily operations as well as its approximately 50 employees. For fiscal year 2019, the District had \$42.1 million in operation revenues and \$41.3 million in operating expenses.
