# AUDIT RESULTS

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Skagit Regional Health from January 1, 2019 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements, credit cards and travel expenditures
- Payroll gross wages, production model payments and electronic funds transfers
- Procurement public works and professional services
- Self-insurance workers compensation and unemployment compensation

## INFORMATION ABOUT THE DISTRICT

Skagit County Public Hospital District No. 1, doing business as Skagit Regional Health, currently operates Skagit Valley Hospital, a 137-bed acute care hospital, Cascade Valley Hospital, a 48-bed acute care facility located in Arlington, WA and Skagit Regional Clinics, a multi-specialty Clinic with 24 locations. Skagit Regional Health employed 195 providers in 2019; this count includes 30 residents. In addition, the District operates the Cancer Care Center, two Wound Clinics, an ASC and a Physical Therapy Clinic that is located at the Mount Vernon YMCA. Excluding newborns, the District had 40,594 acute care patient days in 2019 for both facilities, and a total of 338,697 primary and multi-specialty clinic visits in 2019.

An elected, seven-member Board of Commissioners governs the District. The Board appoints the Chief Executive Officer to oversee the District's daily operations as well as active employees of 2,660 in 2019. The District's primary source of operating revenue is from patient services. For 2019 the District operated on approximately \$425 million.
