AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Seattle Chinatown International District Preservation and Development Authority from January 1, 2018 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Authority's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Financial condition
- Electronic fund transfers
- Bonus and incentive payments

Federal grant programs

A firm of certified public accountants evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Authority's major federal programs. That report includes a federal finding regarding a blended component unit distributing funds to the Authority from surplus cash in the same accounting period as the annual surplus cash calculation.

INFORMATION ABOUT THE AUTHORITY

The Seattle Chinatown International District Preservation and Development Authority (SCIDpda) was established by a charter issued by the city of Seattle on December 16, 1975. The purpose of the Authority is to preserve, promote, and develop the Seattle Chinatown-International District as a vibrant community and unique ethnic neighborhood.

The most significant areas of work are:

- Property Operations: SCIDpda owns and/or manages 358 low-income residential units and 160,000 square feet of commercial and retail space. The majority of the residential properties provide low-income housing.
- Real Estate Development: SCIDpda develops new real estate projects and rehabilitated historic buildings to meet the community's needs such as affordable housing for family-sized households, commercial space for service-providers to seniors and children, and encouraging future growth in the Chinatown International District.
- Community Initiatives: SCIDpda serves as a steward of the community's economic health and development of the neighborhood, and a vehicle for the engagement of residents, business owners, and stakeholders of the neighborhood to work on community development projects and issues.

The Authority is governed by a Board of Directors of up to 17 members. The Authority is supported primarily through revenue from service agreements and rental income.
