#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Evergreen School District No. 114 from September 1, 2019 through August 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Use of restricted funds bond proceeds, local revenues, professional learning, ASB and Capital Project funds
- Accounts payable general disbursements
- Associated Student Body (ASB) activities fundraisers
- Skill Center cash receipting, including timeliness and completeness of deposits and voids and adjustments, and tracking of inventory items
- Procurement public works, purchases, and professional services

- Payroll furloughs and leave accruals
- Compliance with public works projects prevailing wages, change orders, and retainage requirements

#### **INFORMATION ABOUT THE DISTRICT**

Evergreen School District No. 114 serves approximately 25,100 students in kindergarten through 12th grade. Located in Clark County, the District operates 36 schools, including six high schools, six middle schools, 21 elementary schools, the Cascadia Tech Academy, Home Choice Academy, and the 49th Street Academy.

An elected, five-member Board of Directors governs the District. The Board appoints management, sets the budget and holds other financial responsibilities. The District operates on a \$386 million annual budget, with staff of approximately 3,750 employees.
