# AUDIT RESULTS

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Walla Walla School District No. 140 from September 1, 2019 through August 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement public works
- Payroll cash outs and supplemental contracts
- Tracking and monitoring of theft sensitive assets such as computers
- Use of restricted funds professional learning
- Compliance with enrichment levy plan approval
- Establishment of local revenue and expenditure accounts
- Financial condition
- Accounts payable electronic funds transfers

## INFORMATION ABOUT THE DISTRICT

Walla Walla School District No. 140 provides a full range of school programs and services including elementary, middle school, high school, vocational education, bilingual education, special education, pupil transportation and food services. The District operates 11 schools and serves over 5,500 students in Walla Walla County.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent who is responsible for day-to-day operations and oversees about 405 certificated and 401 classified employees. The District had revenues of about \$94 million for the 2019-2020 school year.
