#### AUDIT RESULTS

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, the State-Tribal Education Compact School operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Chief Leschi Schools from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the State-Tribal Education Compact School's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll contracts and payment accuracy
- Use of restricted funds Professional Learning Allocation
- Student enrollment reporting review basic education enrollment for student eligibility
- Student transportation reporting review for student ridership counts that drive funding
- Electronic Funds Transfers (EFT) controls over disbursements
- Subfunds establishment of revenue and expenditure accounts

## INFORMATION ABOUT THE STATE-TRIBAL EDUCATION COMPACT SCHOOL

Chief Leschi Schools 27901 established under RCW 28A. 715.010, opened in September 2018 as a Washington State-Tribal Education Compact School, located in Pierce County. For school year 2019 Chief Leschi Schools served approximately 600 students in grades K-12. The Chief Leschi Schools operates a single K-12 school, which includes elementary, middle school, and high school programs.

The school received approximately \$6 million in direct state funding for fiscal year 2019. As a sovereign nation, the Chief Leschi Schools Board and Puyallup Tribe of Indians Council has ultimate control over the educational needs of the students attending Chief Leschi Schools.
