## **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Bellingham-Whatcom Public Facilities District from January 1, 2018 through December 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2020, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements
- Open public meetings documentation of minutes, executive sessions and special meetings
- Financial condition

## INFORMATION ABOUT THE DISTRICT

The Bellingham-Whatcom Public Facilities District was formed in July 2002 as a joint effort between the City of Bellingham and Whatcom County. The District's mission was to fund a Regional Center and Cultural District located in downtown Bellingham that would create economic growth and lay a foundation for further public and private investment in the community. The District has funded two major renovations to the Mount Baker Theatre and constructed the Whatcom Museum's Lightcatcher Building.

The District is governed by a board of directors and an interlocal agreement between the District, Bellingham, Whatcom County, Blaine, Everson, Ferndale, Lynden, Nooksack, and Sumas. The District completed its capital projects several years ago and its board now meets twice a year for State-required financial reporting. It is supported by City of Bellingham staff on an as-needed basis. Total expenditures in 2018, 2019 and 2020 were \$1,411,651, \$1,845,495 and \$1,923,631 respectively.
