#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Okanogan County Public Health from January 1, 2019 through December 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2020 and 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements, credit cards and employee reimbursements
- Self-insurance for unemployment compensation
- Controls over fuel cards
- Payroll stipends paid during pandemic

#### **INFORMATION ABOUT THE DISTRICT**

Okanogan County Public Health, formerly the County Health Department, was established in December 1986 separate of Okanogan County. The District's mission is to promote health, prevent conditions of disease or disability and to protect the health of the residents of Okanogan County. The District provides various services including child and adult immunizations, food handler classes and permits, and sewage permits.

A seven-member Board of Directors governs the District, consisting of three elected County Commissioners, one appointed official from a participating city and three members appointed by the Board of Health. The Board appoints an Administrative Team which consists of an Environmental Health Director and a Community Health director to oversee the District's daily operations as well as its 10 employees. The District's revenue sources include grants, permit fees and service fees. The District operated on a \$1.1 million and a \$1.6 million annual budget in 2019 and 2020, respectively.
