## **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of West Pierce Fire and Rescue from January 1, 2020 through December 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Financial condition
- Open public meetings documentation of minutes, executive sessions and special meetings
- Payroll leave cash outs
- Accounts payable general disbursements, credit cards, travel expenditures, electronic funds transfers and employee travel advances

# INFORMATION ABOUT THE DISTRICT

Pierce County Fire Protection District No. 3 was established in August 1944 by public vote. On March 1, 2011, Pierce County Fire District No. 3 and Pierce County Fire District No. 2 officially merged to become Pierce County Fire Protection District No. 3, doing business as West Pierce Fire and Rescue.

The District provides contracted fire protection and emergency medical services to approximately 100,262 residents in the cities of Lakewood and University Place, as well as the Town of Steilacoom.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's day-to-day operations and its roughly 200 employees. The District's annual budget for expenditures was \$42,876,648 in 2020.
