AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of King County Water District No. 49 from January 1, 2018 through December 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2020, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Selected IT security policies, procedures, practices, and controls protecting financial systems, IT systems and data: backup and recovery and system conversion
- Accounts payable electronic funds transfers
- Self-insurance for unemployment
- Contract compliance cash receipting and deposit timeliness
- Financial condition

INFORMATION ABOUT THE DISTRICT

King County Water District No. 49 is a municipal corporation formed in King County. The District's primary activity is to provide water services to approximately 16,000 residential and commercial users within the District's boundaries, which encompass parts of Burien, SeaTac and Normandy Park. Its primary source of revenue is water sales, and it purchases all of its water from the City of Seattle.

The District is governed by an elected, three-member Board of Commissioners. The Board appointed Superintendent and Office Manager to oversee the District's daily operations as well as its seven employees. In April 2019, the Board made the superintendent the general manager.
