# **AUDIT RESULTS**

### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Skagit Regional Health from January 1, 2020 through December 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable review of internal Vendor Master File to identify and eliminate duplicates
- Foundation and donations compliance with term of agreements including use of restricted funds
- Compliance with debt and bond covenants
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition review for indications of financial distress

## INFORMATION ABOUT THE DISTRICT

Skagit County Public Hospital District No. 1, a municipal corporation which does business under the name Skagit Regional Health, operates Skagit Valley Hospital, a 137 licensed bed acute care hospital located in Mount Vernon, Washington, Cascade Valley Hospital, a 48 licensed bed acute care hospital located in Arlington, Washington and the Skagit Regional Clinics, a 222-member multi-specialty group providing primary and specialty services through its network of 19 clinics located in Skagit and North Snohomish County. In addition, the District operates the Cancer Care Center, two Wound Clinics, an ASC and a Physical Therapy Clinic that is located at the Mount Vernon YMCA. Excluding newborns, the District had 40,302 inpatient days in 2020 for both facilities, and a total of 320,912 primary and multi-specialty clinic visits in 2020.

An elected, seven-member Board of Commissioners governs the District. The Board appoints the Chief Executive Officer to oversee the District's daily operations as well as 2,092 FTEs in 2020. The District's primary source of operating revenue is from patient services. For 2020 the District operated on approximately \$428 million.
