# **AUDIT RESULTS**

# **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to theft-sensitive assets and use of restricted funds that we communicated to District management and the Board of Directors in a letter dated March 23, 2022. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

# About the audit

This report contains the results of our independent accountability audit of Mount Baker School District No. 507 from September 1, 2019 through August 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements and credit cards
- Use of restricted funds professional learning
- Use of restricted funds local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Controls over payroll direct deposits
- Select IT security policies, procedures, practices, and controls protecting data

- Software conversion
- Tracking and monitoring of theft sensitive assets, such as computers and electronic equipment
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

# **INFORMATION ABOUT THE DISTRICT**

Mount Baker School District No. 507 provides educational services to approximately 1,725 students in preschool through 12th grade in Whatcom County. The District operates one high school, one middle school, three elementary schools, a preschool and an alternative program.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations. Revenue is derived from state apportionment, federal grants and local property taxes. For fiscal year 2021, the District's total expenditures were approximately \$31.75 million.
