#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Charter Public School operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to payroll that we communicated to Charter Public School management and the Board of Directors in a letter August 17, 2022. We appreciate the Charter Public School's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Rainier Valley Leadership Academy from September 1, 2020 through August 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Charter Public School's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages, stipends and incentive pay
- Apportionment basic enrollment, transportation, and special education
- Open public meetings compliance with minutes, meetings and executive session requirements
- Use of restricted funds professional learning, supplemental contracts, and local revenue subfund
- Tracking and monitoring of theft sensitive assets, such as computers and tablets

#### **INFORMATION ABOUT THE CHARTER PUBLIC SCHOOL**

Rainier Valley Leadership Academy, located in King County, provided educational services to scholars in grades 6-11 during the 2020-2021 school year.

The Charter Public School is a 501c3 nonprofit corporation established under RCW 28A.710.020 and governed by a three to 25 member appointed Board of Directors that establishes policies for the Charter Public School according to the terms of a renewable, five-year charter contract executed under RCW 28A.710.160.

Rainier Valley Leadership Academy is authorized by Washington State Charter School Commission to operate a 6-12 charter public school by a five-year contract effective August 22, 2017 and terminating August 22, 2022. The school has completed the renewal process with the Charter School Commission as of December 2021 and received a five-year contract renewal effective August 2022 through August 2027.

The Charter Public School received approximately \$4 million in direct state and federal funding for fiscal year 2020-2021. The Charter Public School operated in one building and employed approximately 30 employees.
