## **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Lynnwood Public Facilities District from January 1, 2021 through December 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Software conversion evaluated design of controls
- Procurement purchases
- Accounts payable general disbursements at Lynnwood Convention Center
- Financial condition reviewing for indications of financial distress
- Open public meetings compliance with minutes, meetings and executive session requirements

## INFORMATION ABOUT THE DISTRICT

The Lynnwood Public Facilities District was created on August 24th, 1999 to establish, finance, design, construct, operate and maintain the Lynnwood Convention Center. The mission of the District is to serve as an economic catalyst for the community through the development of public facilities. The Lynnwood Convention Center contributes to the economic vitality and cultural pride of the region by hosting local, regional, and state meetings and events.

A five-member Board of Directors is appointed by the Lynnwood City Council to provide governance to the District. In 2021, the District had total revenues of \$6,072,563 and total expenses of \$4,394,944. The District has three employees.
