AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the City of Brewster from January 1, 2019 through December 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the City's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2021, 2020 and 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Cash receipting timeliness and completeness of deposits
- Accounts payable general disbursements and employee reimbursements
- Payroll gross wages and overtime
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE CITY

The City of Brewster, located in Okanogan County, was incorporated in 1910 and has a population of approximately 1995 citizens.

The City is administered by a mayor-council form of government with five elected Council Members and an independently elected Mayor. The City reported operating expenditures of \$4,216,883 in 2019, \$4,666,077 in 2020 and \$4,004,672 in 2021. Its 18 full-time employees provide an array of services including water, sewer, garbage, police, fire, Municipal Court, public improvements, planning and economic development.
