#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Consolidated Diking Improvement District No. 3 of Cowlitz County from January 1, 2019 through December 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2021, 2020 and 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements and credit cards
- Payroll commissioner compensation
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### **INFORMATION ABOUT THE DISTRICT**

Cowlitz County Consolidated Diking Improvement District No. 3 was established to protect property owners from the flood waters of the Coweeman and Cowlitz rivers within Cowlitz County. The District operates and maintains a system of dikes, drains, drainage ditches, pumps and other equipment and facilities which operate to remove storm water within its boundaries.

The District is governed by a three-member Board of Supervisors who are independently elected by residents within the District. The District contracts with Cowlitz County's Department of Public Works to perform the majority of its administrative and management functions. One of the District's Board Members acts as a part-time pump operator. The District has no other employees. For the 2019, 2020 and 2021 fiscal years, the District reported annual expenses of approximately \$354,300, \$443,400 and \$253,600, respectively.
