AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, College operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, during the audit certain matters came to our attention that are currently under investigation.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Bellevue College from July 1, 2017 through June 30, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the College's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2021, 2020, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – credit cards and electronic funds transfers (EFT)
- Cash receipting – timeliness and completeness of deposits, voids and adjustments at Student Financial Services
- Payroll – special pay and settlement pay
- Procurement – public works and purchases
- Open public meetings – compliance with minutes, meetings and executive session requirements
- Financial condition – reviewing for indications of financial distress

RELATED REPORTS

Financial

Our opinion on the College's financial statements is provided in a separate report, which includes the College's financial statements. That report is available on our website, <http://portal.sao.wa.gov/ReportSearch>.

We also perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE COLLEGE

Bellevue Community College was founded in January 1966, and officially changed its name to Bellevue College on April 13, 2009. The College is one of 30 community and technical colleges in the state and is the largest single campus community college in Washington, serving more than 24,192 students each year. The College is located in Bellevue and offers a broad selection of credit and non-credit programs in fields leading to Associate Degrees and Certificates in professional and technical fields, in addition to Applied Bachelor and Bachelor of Science Degrees.

A six-member Board of Trustees governs the College. Board Members are appointed by the Governor and each serve a term of five years. For fiscal year 2021, the Community College had an operating budget of approximately \$115.9 million. The primary revenue sources are student tuition and fees and an apportionment from the state. The Community College has approximately 1,500 employees.
