# **AUDIT RESULTS**

# **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

# About the audit

This report contains the results of our independent accountability audit of Mason General Hospital and Family of Clinics from January 1, 2020 through December 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Software conversion billing system
- Payroll gross wages and bonus payments
- Accounts payable general disbursements and electronic funds transfers
- Accounts receivable patient billing, adjustments and collections
- Self-insurance for health and welfare
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

# **INFORMATION ABOUT THE DISTRICT**

Mason General Hospital and Family of Clinics provides health care services including an acute care hospital, an emergency room, Mason General Hospital Eye Clinic, Mason General Hospital Family Health, Mason General Hospital Shelton Orthopedics, Mason General Hospital Surgery Clinic, Mountain View Women's Health Clinic, Oakland Bay Pediatrics, Shelton Family Medicine, Mason General Hospital Ankle & Foot, Olympic Physicians, Hoodsport Family Clinic, and related ancillary procedures. A 60,000 square foot Medical Office Building construction project was substantially completed in 2019, to house nine of the ten surrounding clinics.

An elected, three-member Board of Commissioners governs the District. Board Members serve staggered, six-year terms. The Board appoints management to oversee the District's daily operations as well as its approximately 750 employees and 65 volunteers.
