AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Tacoma Transportation Benefit District from January 1, 2020 through December 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable allowability of general disbursements
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE DISTRICT

November 2012, the Tacoma City Council created the Tacoma Transportation Benefit District (TBD) through adoption of Ordinance 28099. The TBD was established for the purpose of acquiring, constructing, improving, providing, and funding transportation improvements within the TBD consistent with any state, regional, or local transportation plans, and necessitated by existing or reasonably foreseeable congestion levels.

The District is governed by a Board, comprised of Tacoma City Councilmembers acting ex officio and independently of their elected position, as required by the authorizing state law. City management has operational responsibility and services are provided entirely to the City. In November 2012, the District Board imposed a vehicle license fee of \$20 within the District's boundaries. The fee was first collected in June 2013 by the Washington State Department of Licensing. The \$20 vehicle license fee generates approximately \$5M in a biennium.

In 2015 Tacoma residents passed District Proposition A, which permits the TBD to levy an additional sales tax of 1/10 of one percent for a period of 10 years. Proposition A is projected to generate \$4.5 million per year. The additional funding will go towards transportation projects outlined in the Comprehensive Transportation Program including permanent pothole repair, street resurfacing, maintenance and improvements to arterials and freight access roads, installation of school crossing beacons, and building missing sidewalks. The additional sales tax is effective for 2016 to 2025.
