#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Pool operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Association of Washington Cities Risk Management Service Agency from January 1, 2021 through December 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Pool's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Risk pool membership eligibility
- Procurement service contracts
- Selected IT security policies, procedures, practices and controls protecting financial systems patch management and user access
- Accounts receivable rate calculations for billings
- Compliance with solvency requirements
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### **INFORMATION ABOUT THE POOL**

The Association of Washington Cities Risk Management Service Agency is a municipal self-insurance pool that was formed on January 1, 1989 and is located in Thurston County. The Pool provides property and liability coverage to 106 participating members made up of cities, towns and other local governmental entities throughout the State of Washington. In lieu of having employees, the administrative functions of the Pool are performed under contract with the Association of Washington Cities (AWC) and the individuals who perform services for the Pool are all employees of AWC.

The Pool is governed by a sevem-member Board of Directors comprised of elected city officials within the state. The primary source of revenue for the Pool is member assessment fees and its major expenses include payments of claims and payments for insurance coverage. For fiscal years 2021 and 2022, the Pool had operating revenues of \$9,450,135 and \$9,508,414, respectively.
