AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Charter Public School operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to safeguarding of assets that we communicated to Charter Public School management and the Board of Directors in a letter dated May 9, 2023. We appreciate the Charter Public School's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Rainier Valley Leadership Academy from September 1, 2021 through August 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Charter Public School's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2022, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – employee reimbursements and credit cards
- Tracking and monitoring of theft sensitive assets, such as computers and electronics, school equipment and furniture
- Payroll – gross wages, bonus and incentive payments
- Compliance with supplemental contracts for enrichment activities

- Use of restricted funds – professional learning
- Student enrollment reporting – basic education
- Open public meetings – compliance with minutes, meetings and executive session requirements

INFORMATION ABOUT THE CHARTER PUBLIC SCHOOL

Rainier Valley Leadership Academy, located in King County, provided educational services to scholars in grades 6-12 during the 2021-2022 school year.

The Charter Public School is a 501(c)3 nonprofit corporation established under RCW 28A.710.020 and governed by a three to 25 member appointed Board of Directors that establishes policies for the Charter Public School according to the terms of a renewable, five-year charter contract executed under RCW 28A.710.160.

Rainier Valley Leadership Academy is authorized by the Washington State Charter School Commission. It was established by a five-year contract effective August 22, 2017, and terminating August 22, 2022. The school has completed the renewal process with the Washington Charter School Commission as of December 2021 and received a five-year contract renewal effective August 2022 through August 2027.

The Charter Public School received approximately \$3.6 million in direct state and federal funding for fiscal year 2022. The Charter Public School operates in one building and employs approximately 30 employees.
