# **AUDIT RESULTS**

## **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

# About the audit

This report contains the results of our independent accountability audit of Tacoma School District No. 10 from September 1, 2021 through August 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2022, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Software conversion general ledger
- Student enrollment reporting basic education
- Use of restricted funds professional learning and local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Associated Student Body activities at Stadium High School student council minutes, fundraisers, and House Bill 1660
- Accounts payable travel expenditures
- Procurement –purchases, purchasing exemptions, and professional services

- Tracking and monitoring of theft sensitive assets, such as computers, tools, and equipment
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

# **INFORMATION ABOUT THE DISTRICT**

Tacoma School District No. 10 is located in Pierce County and is one of the largest school districts in the state. The District operates eight traditional high schools, three alternative learning high schools, 13 middle schools, 36 elementary schools, eight alternative learning sites, and four early learning centers. The District provides educational services to approximately 28,000 students from preschool through 12th grade.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its nearly 5,000 employees.
