AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Port of South Whidbey Island from January 1, 2020 through December 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Port's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2022, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages, overtime, and electronic funds transfers
- Cash receipting timeliness and completeness of deposits, voids and adjustments
- Accounts payable credit cards
- Self-Insurance for unemployment compensation
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE PORT

The Port of South Whidbey Island is located in Island County and was incorporated in 1961 as the Port of Langley. The name was changed in 1980. The Port is a special purpose taxing district which provides parking facilities, camping, water-related recreational facilities, and spaces for rent to the general public for event venues and small businesses operations. The Port had operating and tax revenues of approximately \$1,185,000, \$1,198,000 and \$1,199,000 for the years 2020, 2021 and 2022, respectively.

The Port currently has six full-time employees, seven part-time employees, and occasional or seasonal assistance throughout the year. The Port operates under the laws of the state of Washington applicable to Port Districts under Title 53 RCW. An elected, three-member Board of Commissioners governs the Port. Each Commissioner serves a six-year term.
