#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to stormwater utility billing that we communicated to City management and the Mayor and City Council in a letter dated November 16, 2023. We appreciate the City's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Longview from January 1, 2021 through December 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the City's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts receivable utility billing and utility discount program
- Payroll gross wages, overtime, and retroactive payments
- Procurement public works and professional services
- Compliance with public work projects prevailing wages, change orders, and retainage requirements
- Accounts payable general disbursements, credit cards, and electronic funds transfers

- Equipment rental and replacement establishment of rates and billing accuracy
- Self-insurance for unemployment and workers compensation
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### Financial

#### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. That report includes a federal finding regarding noncompliance with federal suspension and debarment requirements. #### **INFORMATION ABOUT THE CITY**

The City of Longview, incorporated in 1924, is the largest city in Cowlitz County and it serves approximately 38,620 citizens. The City provides services including police, fire, water, sewer, garbage collection, parks and recreation, planning and building, library and general administrative services.

An elected, seven-member council governs the City. The Council appoints a City Manager to oversee the City's daily operations. In 2021 and 2022, the City had revenues of \$87.7 and \$96.2 million, respectively.
