AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, College operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Green River College from July 1, 2019 through June 30, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the College's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2023, 2022, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Local Funds: bank reconciliations
- Cash receipting – timeliness of deposits
- Payroll – gross wages, overtime, and leave buyouts
- Accounts Payable – purchase cards, general disbursements & electronic funds transfers
- Compliance with state & federal grant requirements
- Software implementation & data conversion

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, agencies, departments and offices that are part of the state's reporting entity. The results of that audit are published in a report issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE COLLEGE

Green River College is a two-year public college founded in 1965. It is centrally located between Seattle and Tacoma in Auburn. In addition to the main campus in Auburn, it has satellite campuses located in Enumclaw, Kent and downtown Auburn. The College offers baccalaureate degrees, associate degrees and certificates in professional and technical fields and academic transfer as well as customized training, developmental and basic skills programs including high school diplomas and continuing education. The College serves approximately 12,500 students annually. The College receives most of its revenue from student tuition and fees and state funding. The 2022-2023 operating budget was approximately \$157 million, of which the state appropriated approximately \$43.7 million.

A five-member Board of Trustees, appointed by the Governor, is responsible for oversight of the College's operations. The College employs approximately 182 full-time faculty members, 492 part-time faculty members and 837 staff and student employees.
