AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Lewis County Public Facilities District from January 1, 2020 through December 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2022, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement public works and purchasing exemptions
- Compliance with public works projects prevailing wages, change orders, and retainage requirements
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE DISTRICT

The Lewis County Public Facilities District (LC PFD) was created by legislation of the 2008 Washington State Legislature to develop an exposition/event center in Lewis County. The Lewis County Board of County Commissioners by Resolution constituted the LC PFD with a five-member Board of Directors which the Commissioners appoint.

In 2012 an Interlocal Agreement was signed by the LC PFD, the City of Centralia, and the Centralia School District to create and manage a sports complex on City of Centralia and School District property, and to construct and maintain an event center. The LC PFD owns the event center but contracts out management of the event center to private enterprise. The District is administered by an appointed, five-member Board of Directors. The District operated on budgets of approximately \$600,000 in 2020, \$725,000 in 2021 and \$775,000 in 2022.
