AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Center operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of MACECOM from January 1, 2020 through December 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Center's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2022, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts receivable billing for user service fees
- Accounts payable credit cards
- Payroll electronic funds transfers
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE CENTER

Mason County Emergency Communications Center, doing business as MACECOM, is an emergency communication services center providing enhanced 9-1-1- services and consolidated law enforcement, fire and medical dispatch services. The Center serves approximately 61,800 citizens in Mason County.

A five-member Legislative Board governs the Center. The Board is appointed from and serves the following participating local governments: Mason County, City of Shelton, Squaxin Island Tribal Police, Skokomish Indian Tribe, Mason County Fire District No. 1, North Mason Regional Fire Authority, Mason County Fire District No. 3, Mason County Fire District No. 4, Mason County Fire District No. 5, Mason County Fire District No. 6, Mason County Fire District No. 9, Mason County Fire District No. 11, Mason County Fire District No. 12, Mason County Fire District No. 13, Mason County Fire District No. 16, Mason County Fire District No. 17 and Mason County Fire District No. 18. The Legislative Board appoints a Director to oversee the Center's daily operations as well as its approximately 20 employees. For fiscal years 2020, 2021 and 2022, the Center operated on annual budgets of approximately \$2.4 million, \$2.7 million and \$2.8 million, respectively.
