#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Housing Authority operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Housing Authority of the City of Everett from July 1, 2021 through June 30, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Housing Authority's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2023 and 2022, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements, credit cards, travel expenditures, and employee reimbursements
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Housing Authority's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. #### **INFORMATION ABOUT THE HOUSING AUTHORITY**

The Housing Authority of the City of Everett was created in 1942 to provide safe, decent, sanitary, and affordable housing to low-income families and individuals. The Housing Authority's service area includes 28 square miles within the city of Everett plus an unincorporated area surrounding the city's boundary.

A six-member Board of Commissioners governs the Housing Authority. The Mayor of the city appoints the Board Members. The Board appoints an Executive Director to oversee the Housing Authority's daily operations as well as its approximately 125 employees. For fiscal year 2023, the Housing Authority had operating revenue of \$76,764,712. The Housing Authority owns one public housing project which is vacant and has been approved for disposition by HUD. Housing includes senior-only units, senior and disabled-only units, and non-designated units. The Housing Authority owns and manages 1,984 subsidized and nonsubsidized rental housing units either directly or in conjunction with our tax credit partnerships.

Through its Section 8 Housing Choice Voucher Program, EHA currently receives an allocation of 3,759 vouchers of various types per month from HUD. This equated to 45,108 voucher unit months during the fiscal year. Section 8 vouchers provide rental assistance to qualified low-income households to subsidize the rental of apartments and houses. The Housing Authority receives approximately 74 percent of its operating revenue in grants and subsidies from HUD. The Housing Authority is the general partner in seven limited partnerships, EHA – Broadway Plaza Limited Liability Limited Partnership, Pivotal Point Limited Liability Limited Partnership, Bakerview/Grandview Affordable Housing Limited Liability Limited Partnership, Everett Affordable Housing Portfolio Limited Liability Limited Partnership, EHA Senior Housing I Limited Liability Limited Partnership, Wiggums Park Place Limited Liability Limited Partnership and Everett Housing Legacy Limited Liability Limited Partnership. EHA sponsors and manages eleven 501(c)3 non-profit organizations which provide 454 units of low-income housing to residents throughout Snohomish County.
