AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Charter Public School operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Lumen Public School from September 1, 2022 through August 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Charter Public School's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – credit cards
- Payroll – electronic funds transfers, leave balances, and leave accruals
- Compliance with supplemental contracts for enrichment activities
- Student enrollment reporting – basic education
- Use of restricted funds – professional learning and local revenue for enrichment activities
- Open public meetings – compliance with minutes, meetings and executive session requirements

INFORMATION ABOUT THE CHARTER PUBLIC SCHOOL

Lumen Public School, located in Spokane County, provided educational services to approximately 36 students in grades 9-12 during the 2022-2023 school year. The Charter Public School is a 501(c)(3) nonprofit corporation established under RCW 28A.710.020 and governed by a 5 to 12 member appointed Board of Directors, that establishes policies for the Charter Public School according to the terms of a renewable, five-year charter contract executed under RCW 28A.710.160.

Lumen Public School is authorized by Spokane Public Schools established by a five-year contract effective August 31, 2020 and terminating August 30, 2025. The Charter Public School received about \$2.1 million in direct state and federal funding for fiscal year 2023. The Charter Public School operates in one building and employs approximately 19 employees.
