# **AUDIT RESULTS**

## **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to the use of restricted funds for local revenue for enrichment activities and Associated Student Body activities that we communicated to District management, the Superintendent, and Board of Directors in a letter dated May 15, 2024. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

# About the audit

This report contains the results of our independent accountability audit of Kelso School District No. 458 from September 1, 2021 through August 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2023 and 2022, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Use of restricted funds professional learning and local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Procurement public works and professional services
- Associated Student Body (ASB) activities fundraisers, gate receipts, inventory, student store, and cash receipting

- Student enrollment reporting special education
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

# **INFORMATION ABOUT THE DISTRICT**

Kelso School District serves approximately 4,950 students in kindergarten through 12th grade in Cowlitz County. The District operates one high school, two middle schools, six elementary schools, and two alternative programs. Alternative programs include an alternative high school and the online Kelso Virtual Academy.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operation as well as its approximately 750 employees. For fiscal years 2022 and 2023, the District had annual revenues of approximately \$102 million and \$99 million, respectively.
