# **AUDIT RESULTS**

## **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Department operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to ongoing eligibility for designated Main Street Communities that we communicated to Department management and the Executive Director in a letter dated June 24, 2024. We appreciate the Department's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

# About the audit

This report contains the results of our independent accountability audit of the Department of Archaeology and Historic Preservation from July 1, 2019 through June 30, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the Department's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2023, 2022, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Main Street Program: Community status Screening requirements for non-profit organizations seeking admission to the Main Street Program for the preservation and development of historic downtowns.
- Main Street Program: Ongoing eligibility Annual requirements that must be fulfilled by recognized community non-profit organizations to maintain their good standing in the Main Street Program.

- Section 106 review Compliance with National Historic Preservation Act requirements for federal undertakings.
- Blank vendor payments: Review of allowability of payments made to blank vendors.

# **RELATED REPORTS**

### Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, agencies, departments and offices that are part of the state's reporting entity. The results of that audit are published in a report issued by the Office of Financial Management in December of each year and can be found at <u>www.ofm.wa.gov</u>.

# **Federal grant programs**

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

# **INFORMATION ABOUT THE DEPARTMENT**

The Department of Archaeology and Historic Preservation (DAHP) was established by the state Legislature as an agency on July 24, 2005, by RCW 43.334.900, to act as the primary agency in state government with expertise in cultural resources. The agency is responsible for archaeology, human remains, historic buildings, cultural properties, and administering the rural Main Street program. DAHP has federal and state regulatory oversight and is the mandated central repository for all Washington State cultural resource data. The State Historic Preservation Officer (SHPO) serves as the agency Director. DAHP's sole office is located in Olympia and is staffed with 30 employees.

During the 2023-2025 biennium, the Department had an operating budget of approximately \$8 million a year. Along with state appropriations, the Department is supported by federal funding through the U.S. Department of the Interior. DAHP promotes the message that preservation creates an environment that instills civic pride and community spirit and encourages economic development by creating jobs, increasing tax revenue, raising property values, and encouraging community reinvestment. The Department works to preserve significant cultural and historic resources in order to improve, enrich and enliven the state for future generations.
