AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to the District's financial condition that we communicated to District management and the Board of Directors in a letter dated June 27, 2024. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Northshore School District No. 417 from September 1, 2022 through August 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Financial condition reviewing for indications of financial distress
- Student enrollment reporting basic education
- Accounts payable credit cards
- Payroll pay adjustment approvals
- Use of restricted funds professional learning and local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Open public meetings compliance with minutes, meetings and executive session requirements

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. That report includes a federal finding over mobile hotspot data services paid for using Emergency Connectivity Fund program funds. INFORMATION ABOUT THE DISTRICT

Northshore School District No. 417 serves over 22,000 students in a 60 square-mile area of northeast King County and south Snohomish County. The District has 20 elementary schools, six middle schools, four high schools, two alternative high schools, an independent contract learning program, an online academy, and an early childhood education program.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as more than 2,400 teachers and support staff. For fiscal year 2023, the District's general fund expenditures was approximately \$424.5 million.
